PREAMBLE:

Forging partnership and building relationships with fellow institutions, like minded personalities, agencies and NGOs will definitely lead to an active role in the present globalized world. It is, in fact, the need of the hour to work in collaboration to achieve and maintain quality standards in Teaching – Learning – Evaluation, Research and Extension activities. This helps to produce quality student services and may also serve to complement skills and resources between the two parties. Individual academicians from affiliated colleges, and NGOs should join their hands to improve the standards in the field. This collaboration will also help to tackle and find solutions to particularly, the local problems and work together for the sustainable development of the area.

Whereas, Shri Guru Buddhiswami Mahavidyalaya, Purna (Jn.) - 431511 and Science College, Nanded - 431605 have many areas of common interest in Teaching as well as Research, considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academics, education and research.

Now therefore, both the colleges have decided to enter into this Memorandum of Understanding (herein after referred to as MOU), which defines the framework for the cooperation of the two institutions set out in the following sections.

About SGBM

S.G.B.S.P. Sanstha's Shri Guru Buddhiswami Mahavidyalaya, Purna (Jn.), established in 1983, is one of the premiere institutions in the region, proactively engaged in conducting quality teaching and research for the rural, poor and the needy students of the Purna Taluka. The College got re-accredited at 'B' Grade with 2.42 CGPA (2nd Cycle) by NAAC (2016). The quality enhancement measures implemented post – NAAC have subsequently led to get 'A' Grade in the University Academic Audit (2019). As a recognition to our unstinted efforts in the quality education and extension activities, Swami Ramanand Teerth Marathwada University, Nanded has honoured the College with the award of the 'Best College (Rural) in the year 2019.

About SCN

N.E.S. Science College, Nanded is established by Nanded Education Society in June 1963. NES Science College covers above 45 acres of land out of 84 acres of NES Nanded. The college has well-built classrooms, laboratories, administrative blocks, auditorium, playground, canteen, hobby workshop, Glass Blowing unit, ladies room, library lush green garden and open-air theater. The aims and objects of the society shall be to start and takeover educational institutions and to supplement the educational endeavors of the Maharashtra state by imparting to the youths of this state generally and Marathwada particularly, an efficient primary, secondary, technical and university education, with a view to infusing in them the spirit of enlightened and responsible citizenship, worthy of a secular, democratic state. The College got re-accredited with "A" grade by NAAC (CGPA Score 3.38) 3rd cycle, CPE status, DST-FIST, NIRF ranking-72 (year - 2017), and also honored the Best college award by SRTMUN.

BROAD AREAS OF COLLABORATION:

Both Institutes agree to develop the following collaborative activities in the academic areas of mutual interest, on the basis of equality and reciprocity. The two institutions shall seek to promote:

A. Student/Faculty/ Research Facilities Exchange:

- i. Collaboration in teaching, research and development, and consultancy services in the field of mutual interest.
- ii. The exchange of faculty to the mutual benefit of both the institutions.
- iii. The exchange of academic materials and publications
- iv. Conducting guest lectures
- v. Undertaking joint research activities/projects
- vi. Attachment of staff for purposes of curriculum development and review, attendance of courses, upgrading of teaching and research skills.
- vii. Participating in Seminars, Symposiums, and other types of academic discussions.
- viii. Conducting study tours and joint consultancy work.

A specific plan will be worked out for each activity, setting forth detailed arrangements for collaboration will be agreed. Terms and conditions for each visit or an assignment or such exchange, including the financial liabilities will be decided mutually as and when the need arises between the institutes. A separate agreement will be entered into giving such details including terms of exchange of any intellectual property.

B. Student Exchange:

Both Institutes agree that student exchange will be guided by principles listed below. A home institution refers to the institution where a student is a full-time student, and from where he/she is expected to graduate.

- i. Exchange of students will be decided by mutual agreement between the home institution and the host institution for training and awareness programmes.
- ii. Student will continue to be treated as a full-time student at his/her home institution.
- iii. If an exchange student has undertaken research, then the host institution will evaluate the exchange student's performance in the research, and issue a letter to that effect, together with a technical "report" of the research carried out.
- iv. If an exchange student has undertaken research, then the home institution will take note of the performance evaluation and the technical response and take steps in accordance with its own procedures.
- v. Both the institutes agree to provide suitable accommodation and living expenses for student exchange.
- vi. To avail travel expenses, students can apply for existing funding programs at their respective home institution.
- vii. The exchange students will pay tuition and other fees at their home institution.

C. Research and Other Areas:

- i. To exchange information on teaching, learning material and other literature relevant to their educational and research programs.

- ii. The provision of cultural and intellectual enrichment opportunities for staff and students of both the institutes.
- iii. To use laboratory facilities in specific cases for a limited period.
- iv. To permit students, staff, and faculty members to use library facility.

SGBM and SCN do hereby agree that the detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by the two institutions as and when needed. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation.

ARTICLE 1: COORDINATION

Each institution shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee consisting of a programme coordinator from the side of Shri Guru Buddhiswami Mahavidyalaya, Purna (Jn.) Dist. Parbhani, and a programme coordinator from the side of Science College, Nanded - 431605 will periodically review and identify ways to strengthen cooperation between the two institutions.

ARTICLE 2: DISCLAIMER

This MoU is not intended by SGBM and SCN to constitute, create give effect to any formal business organization of any kind. Each party hereto shall act as an independent entity, and neither shall act as an agent of either organization for other purposes. Neither party has the authority to bind the other party.

ARTICLE 3: NONEXCLUSIVITY

The agreement reflected by the provisions of this MoU are non – exclusive in nature and both the parties can enter into cooperative arrangements with any other parties to suit their organizational needs.

ARTICLE 4: CONFIDENTIAL INFORMATION

Shri Guru Buddhiswami Mahavidyalaya, Purna (Jn.) Dist. Parbhani & Science College, Nanded will not absolve any confidential information during the research activity.

ARTICLE 5: INTELLECTUAL PROPERTY RIGHTS

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in both the institutes to this Memorandum.

Both institutes shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both the institutes shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the institutes agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing. Any publication regarding such intellectual property shall only be possible with the prior written consent of both the institutes, such consent not to be

unreasonably withheld. Both the institutes shall be free to use perpetually the results arising out of the collaborating activities for its own internal teaching, research, educational, clinical and publication purposes without the payment of royalties or other fees to the other party.

ARTICLE 6: VALIDITY

The Memorandum shall remain in force for a period of FIVE years commencing from the effective date. Institutions may extend the term by written agreement signed by both after a formal review.

ARTICLE 7: TERMINATION

Either institution may terminate the MOU by giving written notice of six months in advance to the other institution. Once terminated, neither Shri Guru Buddhiswami Mahavidyalaya, Purna (Jn.) Dist. Parbhani nor Science College, Nanded will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, both institutes will ensure that the provisions of this Memorandum shall continue to apply to all activities in progress until their completion.

ARTICLE 8: AMENDMENTS/MODIFICATIONS

This MOU may be amended or modified by a written agreement signed by the representatives of both the institutes.

ARTICLE 9: ADHERENCE TO LAWS

Participating faculties, staff and students involved in any activity under this Memorandum must adhere to the rules and regulations of the participating institutions.

ARTICLE 10: LEGAL IMPLICATIONS

PREAMBLE

Whereas, **N.E.S. Science College, Nanded** and **Netaji Subhashchandra Bose Arts, Commerce and Science College, Nanded** have many areas of common interest in languages, considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academics, education and research.

Now therefore, both the colleges have decided to enter into this Memorandum of Understanding (herein after referred to as MoU), which defines the framework for the cooperation of the two institutions set out in the following sections.

ARTICLE 1: OBJECT

Both Institutes agree to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity. The two institutions shall seek to promote:

a. Faculty/Scientist/Staff Exchanges

- i. The exchange of faculty to the mutual benefit of both institution,
- ii. Collaboration in teaching, research and development, and consultancy studies in the field of mutual interest,
- iii. The exchange of academic materials and publications,
- iv. Conducting lectures,
- v. Undertaking joint research,
- vi. Attachment of staff for purpose of curriculum development and review, attendance of courses, upgrading of teaching and research skills,
- vii. Participating in seminars, symposium, and other types of academic discussion,

A specific plan will be worked out for each activity; setting forth detailed arrangements for collaboration will be agreed.

b. Student Exchange

'Both Institutes' agree that student exchange will be guided by principles listed below. A home institution refers to the institution where a student is a full-time student, and from where he/she is expected to graduate.

- A) Exchange students will be selected by mutual agreement between the institution and the host institution.
- B) An exchange student will continue to be treated as full-time student at his/her home institution.
- C) If an exchange student has undertaken research, then the host institution will evaluate the exchange student's performance in the research, and issue a letter to that effect, together with a technical "report" of the research carried out.
- D) If an exchange student has undertaken research, then the home institution will take note of the performance evaluation and the technical report, and take steps in accordance with its own procedures.
- E) Both institutes agree to provide suitable accommodation and living expenses for student exchange.
- F) To avail travel expenses, students can apply for existing funding programs at their respective institution.
- G) The exchange students will pay tuition and other fees at their home institutions.

c. Other Areas:

- I. To exchange information on teaching, learning material and other literature relevant to their educational and research programs.
- II. The provision of cultural and intellectual enrichment opportunities for staff and students of both institutes.
- III. To use laboratory facilities in specific cases for a limited period.
- IV. To permit students, staff and faculty members to use library facility.

N.E.S. Science College, Nanded and Netaji Subhashchandra Bose Arts, Commerce and Science College, Nanded agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by the two institutions. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation.

ARTICLE 2: COORDINATION

Each institution shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee consisting of a programme coordinator from the side of **N. E. S. Science College, Nanded**, and a programme coordinator from the side of **Netaji Subhashchandra Bose Arts, Commerce and Science College, Nanded** will periodically review and identify ways to strengthen cooperation between the two institutions.

ARTICLE 3: INTELLECTUAL PROPERTY RIGHTS

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MoU shall be vested in both institutes to this Memorandum.

Both institutes shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both institutes shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the institutes agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing. Any publication regarding such intellectual property

shall only be possible with the prior written consent of both institutes, such consent not to be unreasonably withheld. Both institutes shall be free to use perpetually the results arising out of the collaborating activities for its own internal teaching, research, educational, and publication purposes without the payment of royalties or other fees to the party.

ARTICLE 4: VALIDITY

The Memorandum shall remain in force for a period of FIVE years commencing from effective date. Institutions may extend the term by written agreement signed by both after review.

ARTICLE 5: TERMINATION

Either institution may terminate the MoU by giving written notice of six months in advance to the other institution. Once terminated neither **N. E. S. Science College, Nanded** nor **Netaji Subhashchandra Bose Arts, Commerce and Science College, Nanded** will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, both institutes will ensure that the provisions of this Memorandum shall continue to apply to all activities in progress until their completion.

ARTICLE 6: AMENDMENTS/MODIFICATIONS

This MoU may be amended or modified by a written agreement signed by the representatives of both institutes.

ARTICLE 7: ADHERENCE TO LAWS

Participating faculties, staff and students involved in any activities under this Memorandum must adhere to the law of the host countries and rules and regulations of the institutions.

ARTICLE 8: LEGAL EFFECT

Nothing in this Memorandum shall be construed as creating any legal relationship between the institutes. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

ARTICLE 9: DISPUTE RESOLUTION

In case, there be a dispute relating to any aspect of academic cooperation, Principal, N.E.S. Science College, Nanded and Netaji Subhashchandra Bose Arts, Commerce and Science College, Nanded will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.



PREAMBLE :

WHEREAS

AND WHEREAS,




2. Allocation of the projects to the students


One to two Energy Saving projects shall be made available to the students.

This institution has been on the forefront in pursuit of academic excellence and has attended potential for excellence (CPE) status from UGC. The college is DST-FIST sponsored and recently awarded as BEST COLLEGE AWARD by Swami Ramanand Teerth Marathwada University, Nanded. The main objective and mission of college is overall development of students in all respect like academic, physical, mental, spiritual and moral to build up good citizen for the Republic of India. The college has lush green campus of 45 acres of land for curricular and co-curricular activities for stakeholders. The college offers 12 programmes at PG Level and 15 programs with 33-subject combinations at UG level. To keep pace with the advancement and diversification in the field of science and technology some applied subjects like integrated Computer Science, Biotechnology at UG, M.Sc. Biotechnology; and Herbal Medicine at PG level have been introduced. M.Sc. Statistics Course is introduced

from academic year 2022-23. B. Voc. Degree Courses in Plant Tissue Culture Technology and Software Development and B. Voc. Diploma Courses in Clinical Sciences and Medical Lab Technology and Sports Nutrition and Physiotherapy are introduced in academic year 2022-2023.

And

Sevadas Shikshan Prasarak Mandal's Vasantao Naik College, Vasarni, Nanded Established in 1984 and located in Nanded, Maharashtra. The S.S.P.M. Vasantao Naik College, Vasarni, Nanded is a premier college of the country for highest academic standards, different educational programs, grand faculty, and various co-curricular activities and modern infrastructure. S.S.P.M. Vasantao Naik College, Vasarni, Nanded affiliated to Swami Ramanand Teerth Marathwada University the college sustained the highest global standards and best practices in higher education.

PREAMBLE

Whereas, N.E.S. Science College, Nanded and S.S.P.M. Vasantao Naik College, Vasarni, Nanded have many areas of common interest in languages, considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academics, education and research.

Now Therefore, Both the colleges have decided to enter into this Memorandum of Understanding (herein after referred to as MoU), which defines the framework for the cooperation of the two institutions set out in the following sections.

ARTICLE 1: OBJECT

Both Institutes agree to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity. The two institutions shall seek to promote:

a. Faculty/Scientist/Staff Exchanges

- i. The exchange of faculty to the mutual benefit of both institution,
- ii. Collaboration in teaching, research and development, and consultancy studies in the field of mutual interest,
- iii. The exchange of academic materials and publications,
- iv. Conducting lectures,
- v. Undertaking joint research,

- vi. Attachment of staff for purpose of curriculum development and review, attendance of courses, upgrading of teaching and research skills,
- vii. Participating in seminars, symposium, and other types of academic discussion,

A specific plan will be worked out for each activity; setting forth detailed arrangements for collaboration will be agreed.

b. Student Exchange

Both Institute's agree that student exchange will be guided by principles listed below. A home institution refers to the institution where a student is a full-time student, and from where he/she is expected to graduate.

- A) Exchange students will be selected by mutual agreement between the institution and the host institution.
- B) An exchange student will continue to be treated as full-time student at his/her home institution.
- C) If an exchange student has undertaken research, then the host institution will evaluate the exchange student's performance in the research, and issue a letter to that effect, together with a technical "report" of the research carried out.
- D) If an exchange student has undertaken research, then the home institution will take note of the performance evaluation and the technical report, and take steps in accordance with its own procedures.
- E) Both institutes agree to provide suitable accommodation and living expenses for student exchange.
- F) To avail travel expenses, students can apply for existing funding programs at their respective institution.
- G) The exchange students will pay tuition and other fees at their home institutions.

c. Other Areas:

- I. To exchange information on teaching, learning material and other literature relevant to their educational and research programs.
- II. The provision of cultural and intellectual enrichment opportunities for staff and students of both institutes.
- III. To use laboratory facilities in specific cases for a limited period.
- IV. To permit students, staff and faculty members to use library facility.

N.E.S. Science College, Nanded and S.S.P.M. Vasantrao Nalk College, Vasarni, Nanded agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by the two institutions. These terms shall include a

technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation.

ARTICLE 2: COORDINATION

Each institution shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee consisting of a programme coordinator from the side of N. E. S. Science College, Nanded, and a programme coordinator from the side of S.S.P.M. Vasantao Naik College, Vasarni, Nanded will periodically review and identify ways to strengthen cooperation between the two institutions.

ARTICLE 3: INTELLECTUAL PROPERTY RIGHTS

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MoU shall be vested in both institutes to this Memorandum.

Both institutes shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both institutes shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the institutes agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing. Any publication regarding such intellectual property shall only be possible with the prior written consent of both institutes, such consent not to be unreasonably withheld. Both institutes shall be free to use perpetually the results arising out of the collaborating activities for its own internal teaching, research, educational, and publication purposes without the payment of royalties or other fees to the party.

ARTICLE 4: VALIDITY

The Memorandum shall remain in force for a period of FIVE years commencing from effective date. Institutions may extend the term by written agreement signed by both after review.

ARTICLE 5: TERMINATION

Either institution may terminate the MoU by giving written notice of six months in advance to the other institution. Once terminated, neither **N.E.S. Science College, Nanded** nor **S.S.P.M. Vasant Rao Naik College, Vasarni, Nanded** will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, both institutes will ensure that the provisions of this Memorandum shall continue to apply to all activities in progress until their completion.

ARTICLE 6: AMENDMENTS/MODIFICATIONS

This MoU may be amended or modified by a written agreement signed by the representatives of both institutes.

ARTICLE 7: ADHERENCE TO LAWS

Participating faculties, staff and students involved in any activities under this Memorandum must adhere to the law of the host countries and rules and regulations of the institutions.

ARTICLE 8: LEGAL EFFECT



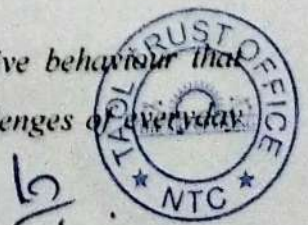
The 'Partners', decided that it was mutually beneficial to have a formal understanding between them in sensitizing the students of the institution about The Art of Living Programs.



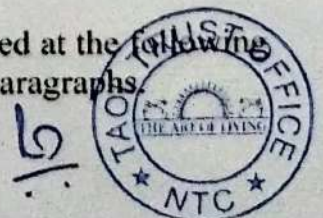

- i. The Life Skills Training program runs over for 4-5 consecutive days for 2-2.5 hours every day. The FDP program runs over for 4 consecutive days for 3 hours every day.
- ii. The Life Skills Training program will be offered to all students of NES. The FDP shall be offered to all faculty and staff.
- iii. The program's financial contribution shall be borne by interested students/faculty of NES on a voluntary basis.

2. NES shall:

6. Modification:



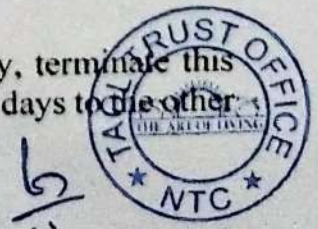

12. Governing Law and Jurisdiction:



URBAN AND RURAL COLLEGES PROGRAM

This Memorandum of Understanding is made at Delhi on 16th March 2023.

BETWEEN

NASSCOM Foundation, a charitable trust registered under the Indian Trust Act, 1882 vide registration number :10479, Permanent Account Number AAATN4866D and having its registered office at A1-125, Lower Ground Floor, Safdarjung Enclave, New Delhi 110021, hereinafter referred to as "NF" (which term shall so far as the context admits be deemed to mean and include its successors, administrators, executors and assignees) of the First Part.

AND

Science College, Nanded located at Nanded, Maharashtra (India) hereinafter referred to as "Science College, Nanded" or "the College" (which term shall so far as the context admits be deemed to mean and include its successors and assignees) of the Second Part,

NF and Science College, Nanded are collectively referred to as the "Parties" and individually as a "Party".

WHEREAS, NASSCOM Foundation has agreed to partner with Science College, Nanded, for the setting up of digital labs under the DIGITAL LABS TO SUPPORT MARGINALISED YOUTH IN SEMI URBAN AND RURAL COLLEGES PROGRAM ("Program").

AND WHEREAS the Program is a CSR funded program for Creating sustainable skill building plans to support students from marginalised communities under Adobe's CSR Mandate and implemented by the NASSCOM Foundation.

NOW IT IS HEREBY MUTUALLY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. The College Responsibilities:

- 1.1. Shall nominate /Identify Director/ HoD, as the SPOC, with adequate accountability and responsibility to be the executive face of the Program in the college. This person must attend regular review calls at a mutually agreed frequency with NF for updates and assessments of the Project. This person shall ideally be a member of the college faculty.
- 1.2. The College Coordinate will be responsible for the following activities of the Project:
 - Installation and commissioning of the digital lab by 24th March, 2023.
 - Impact Reporting - Collecting & Uploading info needed like footfall, photos, milestones, outreach etc.
 - Keyholding - Responsible for keeping the digital lab open and accessible
- 1.3. Shall support with publicity of the Program through the college website.
- 1.4. Shall encourage the Program in a manner so that students will take part in the program on a voluntary basis with flexible timings.
- 1.5. Shall make available the infrastructure and value added services (including IT infrastructure, applications and connectivity) required to run the Program on its own cost.
- 1.6. Shall provide all the support services and facilities to NF and its partners for the said Program.
- 1.7. Shall coordinate with NF and its Partners and facilitate the conduct of events and other engagement programs as per shared plan.

1.8. The college is capable of entering into this Memorandum of Understanding and has all the required permissions for the same.

1.9. Assets Ownership:

The assets provided under the Program shall belong to NASSCOM Foundation and shall be moved out of the College, if NASSCOM Foundation decides to discontinue its engagement with the college in the Program. Subject to any other terms and conditions laid down by NASSCOM Foundation, the College can continue to use the assets if:

- it agrees to sustain the Program without any funding support from NASSCOM Foundation;
- it agrees to maintain the brand name of the program as provided by NASSCOM Foundations separately in writing;
- It agrees to allow students access to the digital labs for ideation, learning and other related activities
- it agrees to opportunities to learn from NASSCOM Foundation's skilling and volunteering Initiatives
- it agrees to create sustainable skill building plans to support students from marginalised communities
- it agrees to facilitate the participation of students in events organized by NASSCOM Foundation and Adobe;

The performance of college on the above points will be monitored by NASSCOM Foundation regularly. The Program will be allowed to continue only on satisfactory assessment of the performance of College on the above points by NASSCOM Foundation. Decision of NASSCOM in this regard shall be final and binding.

2. NF Responsibilities:

2.1. Will supply the equipment for Digital lab

(List of the equipment attached as annexure 1).


2.2. Will keep the college informed of any changes in the program plan;

2.3. NF shall have no liability qua the equipment after the same have been supplied to the College.

3. Other Terms & Conditions for Engagement

The following are other terms and conditions of engagement:

3.1. Terms of engagement: This MoU is valid from date of execution to 31st March 2023, however both parties agree that based on mutual agreement, the terms may be extended. Both parties also agree that terms may be renegotiated.

3.2. **Training Fees:** The College, NF and Partners will not charge any amount on whatsoever account/name from the students in relation to the Program

3.3. **Limitations and Warranties:** Both parties agree that it would be their endeavour to prevent any liability arising out of default or non-compliance of the MoU terms by the other party.

3.4. **Termination:** In case any party to this MoU commit any breach of the terms and conditions of this MoU or violates any statutory provisions or any Government or statutory guidelines or any guidelines issued by the controlling authority, then, in addition to any other remedy available as per law, the other party shall have the right to terminate this agreement by serving at least 15 days' written notice to the defaulting party. However, on such termination, both the parties shall continue to be liable to each other for completion of their mutual rights and obligations under this MoU, which were there on the date of the termination of this MoU.

Both parties to the MoU reserve the right to terminate the MoU with one-month prior notice if in their opinion the Program is not being implemented as per the MoU or the specific aims.

3.5. **Branding:** Both parties shall not use the name and brand of other party or even that of Adobe in any advertisement or make any public announcement without the prior written approval of the respective party whose name is intended to be used in any advertisement or branding.

3.6. **Operational Responsibilities:**

The Digital Lab maintenance and operations will be managed by the College.

4. General terms

4.1. **Indemnification:** Both parties agree to indemnify each other and hold the other party harmless from and against any claim, loss, liability, or expense, including, but not limited to, damages, patent, and trademark infringement, costs and attorneys' fees, arising out of or in connection with any acts or omissions of their agents or employees, as related to the terms of this MoU.

4.2. Any claim, compensation, case initiated by any student against NASSCOM Foundation/ Adobe in relation to the Program due to any acts or omissions of College shall be defended and contested by the College at their sole expenses and cost keeping NASSCOM Foundation /Adobe indemnified from the same.

5.3 **Waiver:** The rights and remedies provided to each of the Parties herein shall be cumulative and in addition to any other rights and remedies provided by law or otherwise. Any failure in the exercise by either Party of its right to terminate this MOU or to enforce any provision of this MOU for default or violation by the other party shall not prejudice such party's rights of termination or enforcement for any further or other's default or violation or be deemed a waiver or forfeiture of those rights.

5.4 **Severability:** If any section or paragraph, or part thereof of this MOU or any document appended hereto or made a part hereof is rendered invalid, ruled illegal by any court of competent jurisdiction, or unenforceable under present or future laws effective during the term of this MOU,

then it is the intention of the Parties that the remainder of the MOU, or any document appended hereto or made a part hereof, shall not be affected thereby unless the deletion of such provision shall cause this MOU to become materially adverse to any Party in which case the Parties shall negotiate in good faith such changes to the MOU, or enter into suitable amendatory or supplementary MOUs, as will best preserve for the Parties the benefits and obligations under such provision.

5.5 Amendment of MOU: The terms and conditions contained in this MOU may be amended or modified only with the mutual consent in writing of both Parties.

5.6 Relationship: The relationship between the Parties is that of principal to principal. Nothing in this MOU shall be taken as constituting a Party an employee or agent of the other Party. The Parties undertake that none of their respective employees and staff shall be construed in any manner, either expressly or by implication, as the employees or agents of the other Party and the other Party shall not be liable in any manner whatsoever for any claims, demands and the like made by them.

5.7 Limitation of Liability:

Except for the indemnification obligations, both parties agree that the liability would be limited to the amount of actual transactions between the two parties

6. Intellectual Property Rights

6.1 Neither Party shall be entitled to use the trademarks, logos or any intellectual property belonging to the other Party and its affiliates in any manner without prior written approval from the other Party. The ownership of all proprietary rights in relation to ideas / products developed created, in the maker labs will lie with the creator/creators of the said property.

7 Notices:

7.1 Any notices under this MOU will be sent by certified or registered mail, return receipt requested, to the respective address of Parties as contained in this MOU. Such notice will be effective upon its mailing as specified.

8 Force Majeure:

8.1 Neither party to this MOU shall be liable for any failure or delay on its part in performing any of its obligations under this MOU, if such failure or delay shall be result of or arising out of Force Majeure conditions and, provided that the party claiming Force Majeure shall use its best efforts to avoid or remove such cause of non-performance and shall fulfil and continue performance hereunder with the utmost dispatch whenever and to the extent such cause or causes are removed.

8.2 Any extraordinary event, which cannot be controlled by the parties, shall for the purpose of this MOU be considered as a Force Majeure event. Such events include acts of God, acts or omissions of any Government or agency thereof, compliance with rules, regulations or order of any Government Authority, pandemic, epidemic. Provided however, if either party claims that existence of any of the aforesaid conditions is delaying or disabling the performance by said party
